re you aware of the new programs available to you and your municipality that could promote your profession, increase revenues, reduce your cost and protect your system from liabilities? Please read below on all the new services that are just a phone call away for you to take advantage of.

- The New York Rural Water Association has a new program to assist rural and small community water and wastewater utility systems in evaluating their energy needs, consumption and costs; recommending measures to reduce energy consumption; and identifying potential funding sources for improvements. This service is free of charge to you. If you are interested, call our office and get on a list to have our staff provide you with an energy assessment.
- The ServLine Program is new and was developed to protect your utility against losses from residential customers' water leaks, and provides the opportunity for them to add service line repair and replacement protection. The water loss protection enhances and expands your current leak adjustment program. This unparalleled loss protection program is significant in reducing utility workload and expenses due to customer leaks. The water loss protection is customized for each utility's leak adjustment program and provides water bill protection from excess water charges resulting from eligible plumbing leaks up to \$2500. There is no deductible and the coverage is limited to one leak every 12 months. The line protection portion is something your residential customers may choose to enroll in and provides broad coverage and saving homeowners from large unexpected line repair and replacement bills. This covers repairs and replacement of water and sewer line up to \$10,000 each, with no deductible and no annual limit. The line protection from starting point of homeowner's responsibility to the foundation of their home. It also includes \$500 for site restoration and \$500 for private paved surfaces such as sidewalks and driveways. The benefits for your utility are improved customer satisfaction while simultaneously offering additional services, reduced workload related to leak adjustments, and improves financial position by additional revenue from new servers and removing all customer leak related costs.

Once a policy is purchased, you will receive access to a data security service website designed to provide online security and privacy information services.
